# REPORT OF THE TRUSTEES YEAR ENDED 31 MARCH 2020

The Trustees present their report and the financial statements for the year ended 31 March 2020.

The information as set out on page 1 forms part of this report. The financial statements comply with statutory requirements and the Statement of Recommended Practice (SORP) - Accounting and Reporting by Charities.

# 1. Structure, Governance & Management

Children's Health and Development in Kenya (CHADIK) was registered as a charity on 10 April 2012 and was established under a Memorandum of Association which sets out its objects and powers and is governed under its Articles of Association.

The Trustees are all familiar with the objects of the charity. They are responsible for strategic direction and policy and they review the risks of operation. They meet on a regular basis as a Management Committee. The Trustees who have served during the year and to the date of this report are set out on page 1.

#### 2. Objectives, Activities and Achievements

#### Objectives:

To benefit the peoples of Kenya by acting as an umbrella / resource body with specific focus supporting outreach medical clinics to areas with no paediatric support.

### **Activities and Achievements:**

The outreach clinics, provided by Gertrude's Hospital Foundation (GHF), which is based in Nairobi, are being carried out on a monthly basis in the Laikipia region of Eastern Kenya.

These clinics reach and diagnose hundreds of sick children in rural areas where local medical facilities are poor or non-existent. Each of the clinics is led by a doctor/paediatrician and includes a nurse/counsellor and a nutritionist.

During the calender year 2019, outreach clinics have been held at Dol Dol, Likii, Solio and Nanyuki. In total, 927 (2018: 985) patients have been examined and treated.

Because of the current Covid-19 virus situation, Gertrude's have advised that they will be suspending the clinics until further guidelines are received from the Kenyan government on travel and direct contact with patients and their families.

Whilst the child cancer awareness project in Kenya is still in its initial stages, with the regular donors continued support, the trustees are still prepared to endorse this development but acknowledge that it is likely that this change in focus would only occur if the rural clinics are discontinued.

# 4. Financial Review

During the year Expenditure exceeded Income by £195 resulting in Unrestricted Funds of £26,430 being available to be carried forward.

During the year the Gertrude's Outreach Clinics benefitted from a grant of £2,400 from the Richard Lawes Foundation.

Apart from the above grant, income during the year was primarily raised from donations from CHADIK's regular supporters who gave most generously, particularly at the various fund raising activities. Wherever possible, these supporter donations were supplemented by Gift Aid.

The Trustees would like to take this opportunity to formally thank the major donors and all the regular supporters for their kind contributions during the year which really made a difference to the ongoing operations and activities.

In respect of the Covid-19 pandemic, whilst the Trustees expect some minor loss of income during 2020, they do not consider this will materially impact incoming resources or the ability of the charity to operate effectively and should not affect the charity as a going concern.

As the Income for the year was less than £25,000, an Independent Examiner's Report was not required.

The Trustees aim to always have a minimum of £15,000 of available reserves so that there is cover for the following year's Outreach Clinics.
